1.	IN-PAYMENT	GST (INCLUDING DUTY EXEMPTION)	GST	For payment of GST for the inward movement of goods into Customs territory.
2.	IN-PAYMENT	DUTY	DUT	For payment of Duty (without GST) for the inward movement of goods into Customs territory.
3.	IN-PAYMENT	DUTY AND GST	DNG	For payment of Duty and GST for the inward movement of goods into Customs territory.
4.	IN-PAYMENT	BLANKET (INCLUDING BLANKET DUTY EXEMPTION AND GST PAYMENT)	BKT	For the payment of Duty and/or GST for the inward movement of the goods into Customs territory over a period of time.
5.	IN-NON-PAYMENT	STORAGE IN FTZ	SFZ	For the temporary storage of imported goods in the Free Trade Zones, pending re-export to another destination or pending local release. This includes the storage of the goods in the second Free Trade Zone.
6.	IN-NON-PAYMENT	FOR RE-EXPORT	REX	For the re-export of the entire import consignment*, be it via the same or different Free Trade Zones.  <u>Note:</u> *not applicable to goods subject to export control by any Controlling Agency.

7.	IN-NON-PAYMENT	APPROVED PREMISES /SCHEMES	APS	For the inward movement of goods into approved premises or approved schemes where Duty or GST payment for these goods are temporarily suspended. This includes the Licensed Warehouse Scheme, Zero GST Warehouse Scheme and the Major Exporter Scheme.
8.	IN-NON-PAYMENT	BLANKET (INCLUDING BLANKET DUTY EXEMPTION AND GST RELIEF)	BKT	For the inward movement of goods (where payment is temporarily suspended or goods have been granted GST relief and/or duty exemption) into Customs territory over a period of time.
9.	IN-NON-PAYMENT	GST RELIEF (AND OR DUTY EXEMPTION)	GTR	For the inward movement of goods (granted GST relief and/or duty exemption) into Customs territory.
10.	IN-NON-PAYMENT	SHUT OUT / DESTRUCTION	SHO/ DES	For the inward movement of goods which have been shut out or are brought into Customs territory for the purpose of destruction.
11.	IN-NON-PAYMENT	TEMPORARY CONSIGNMENTS: - Temporary Import for Exhibition without sales or auctions - Temporary Import for Exhibition with Sales - Temporary Import for Repair - Temporary Import for Other Purposes - Re-import of Temporary Exported Goods	-TCE  -TCS  -TCR -TCO -TCI	For the inward movement of goods (under the Temporary Import Scheme granted by Singapore Customs) into Customs territory, where payment is temporarily suspended and goods must be re-exported over a period of time. This also applies to the re-importation of goods which were previously temporarily exported.

12.	OUT (WITH OR WITHOUT CO)	DIRECT (INCLUDING STORAGE IN FTZ)	DRT	For the export of locally manufactured or GST paid goods, including those goods moved out of the Customs territory for storage in the FTZ, pending export.
13.	OUT (WITH OR WITHOUT CO)	BLANKET	BKT	For the outward movement of goods from customs territory over a period of time. <b>Note:</b> CO applications are not applicable for this Declaration Type.
14.	OUT (WITH OR WITHOUT CO)	APPROVED PREMISES/SCHEMES	APS	For the outward movement/export of goods from approved premises or under approved schemes.
15.
