IMPORT OF BEEF AND BEEF PRODUCTS FROM THE UNITED STATES

In line with the BSE negligible risk status in the United States, AVA has extended the range of US beef products for export to Singapore to include boneless and bone-in beef cuts (from cattle of all ages), processed beef products and offal.

Import of beef cuts must be sourced from establishments on the USDA beef export verification (BEV) program for Singapore. The list of eligible establishments for export of beef cuts and their corresponding contact details can be found in Annex A1 and A2, respectively. Each consignment is to be accompanied with the FSIS standard form 9060-5 and FSIS letterhead certificate (Form 2630-9).

Processed beef products and offal will be subject to AVA's evaluation and approval prior to export as shown in Annex B. Upon approval, these establishments will then be listed specifically for approval of offal / processed beef.

Annex B

Evaluation procedure and import conditions for import of processed beef products and offal from the United States to Singapore

The following information must be submitted by the exporting establishments to AVA for evaluation and approval prior to the initial export of processed beef products and beef offal. Demonstration of compliance as described in (f), by the exporting establishment, is required for each shipment of offal products. The information required for each processed beef product and beef offal product is as follows:

- a. Establishment name, number, address and list of products intended for export
- b. Brief description of the product, including product specification and shelf life of the product
- c. Documentation showing that the establishment is listed on the BEV program
- d. Copy of the process flow chart. The critical control points (CCPs) and temperature control of storage of the final product must be indicated in the flow chart. For offal, evidence that products have been hygienically processed and are fit for human consumption. Establishment processes, including HACCP plans, would be subject to in-person verification during a systems audit.
- e. Product label with information of content (from greatest to least)
- f. For offal, compliance with Singapore's requirements concerning residues in offal tissues.
